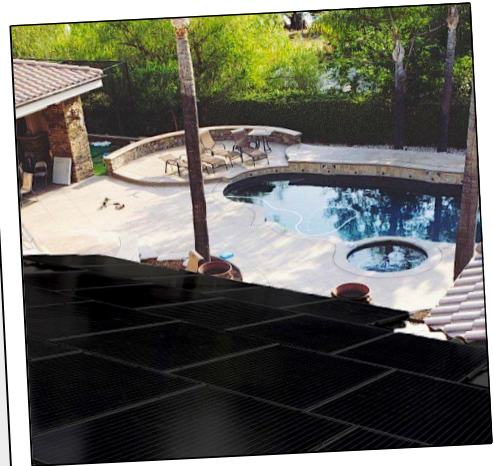

# Terms and Conditions

Consolidated Electrical Distributors, Inc. ("CED") and JinkoSolar (U.S.) Inc. ("JinkoSolar"), together "CED/Jinko", invite you to their Residential and Commercial Photo Contest (the "Contest"). It begins August 1, 2020 and ends October 31, 2020 at 5:00 pm Pacific Standard Time. By submitting an entry, each contestant agrees to the rules of the contest and states that he or she is 18 years or older.

## AGREEMENT TO RULES

By participating, the Competitor ("You") agrees to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of CED/Jinko as final and binding as it relates to the content of this Contest.

## WHO MAY ENTER

Any installer who has installed a system using JinkoSolar modules purchased through a CED branch in the United States may enter. Individuals associated with CED or JinkoSolar, including employees and their immediate family members are not eligible. Competitors shall be 18 years of age or older as of the date of entry. CED/Jinko will determine eligibility in its sole discretion.

## WHAT TO ENTER

Competitors should submit photos of residential or commercial systems they have installed using JinkoSolar modules purchased from a CED Branch after May 1, 2018. Ideal submissions include photographs of the system from multiple angles and viewpoints. Photos with people visible do not qualify and photos must be of a rooftop array.

## HOW TO ENTER

Please submit photographs and requested information online at [cedgreentech.com/eagle-photo-contest-2020](http://cedgreentech.com/eagle-photo-contest-2020). You may enter as many submissions as you like. Photographs (each a "Photo") should be in .jpeg, .jpg, or .png formats and at least a resolution of 300 dpi. Each photograph should be accompanied by the following information in a word document or .pdf file: 1) Residential or Commercial, 2) Installer Name, 3) CED Branch, 4) City and State of Project, 5) Size of System (kW), 6) Part Number of JinkoSolar Modules (ex. JKM310M-60HBL), 7) Other Distinguishing Characteristics, 8) Interconnection Date, 9) Installer Contact Information.

## SOCIAL MEDIA

We encourage You to also share Your Photos on Instagram tagging @cedgreentech and @JinkoSolar\_US and using the hashtag #eaglemodules2020. Note - Instagram photos alone do not qualify; a formal online submission is required.

## JUDGING
